21 students in the first year of master's professional studies, title: Professional Master Nurse

• **PHYSIOTHERAPY**

14 students in the first year of professional master studies, title: Professional Master Physiotherapist

• **MEDICAL RADIOLOGY**

14 students in the first year of professional master's studies, title of professional master of medical radiology.

**Enrollment requirement:**

A person who has completed the first level of basic vocational studies in the following study programs may enroll in the first year of master's studies:

- Master of Professional Studies - Healthcare: appropriate higher education comprising at least 180 ECTS credits, completed basic professional studies - vocational nurse/technician and/or other related study programs.
- Master's degree - Physiotherapy: appropriate higher education of 180 ECTS credits, completed basic vocational studies - professional physiotherapist and/or other related study programs.
- Master of Professional Studies - Medical Radiology: appropriate higher education comprising at least 180 ECTS credits, completed basic professional studies - professional medical radiologist and/or other related study programs.

The basis for determining the order of candidates for enrollment in master's professional studies is the average grade achieved at the first level of basic professional studies and the length of studies at the previous educational level. The average grade achieved at the first level of basic professional studies means the average grade stated in the diploma of completed basic professional studies.

**APPLICATION OF CANDIDATES: On working days starting from 01.06.2026. to 29.06.2026., from 10 am to 3 pm in the School premises.**

When applying, the candidate submits:

- Application for the competition (Application form is available at the School)
- Diploma of completed basic vocational studies and diploma supplement (photocopy certified by a notary, original for inspection)
- Proof of payment of the competition application fee in the amount of 70 euros in dinar equivalent, at the average NBS exchange rate for the 1st day of the month (payment should be made to the School's account).

The list of registered candidates will be published on 30.06.2026. year.

**PUBLICATION OF THE FINAL RANKING LIST: 02.07.2026.**

**REGISTRATION OF ADMITTED CANDIDATES: 03.07-15.07.2026.**

Upon enrollment, the student submits the following documentation:

- A photocopy of the diploma of completed basic vocational studies and the diploma supplement, certified by a notary
- Photocopy of ID card or scanned ID card
- Original permanent birth certificate or certified copy
- Certificate of citizenship
- Medical certificate for further education, not older than six months
- A duly completed and signed index (available at the School)
- Two completed SHW20 forms (available at the School)
- Two photos of 3.5 x 4.5 format
- Proof of payment of administrative costs for enrollment in the amount of 70 euros in dinar equivalent, at the middle exchange rate of the NBS on the first working day of the month for the current month, to the School's accounts:

**Objection to the order of candidates for enrollment in master's professional studies:**

A participant in the competition may file a complaint with the School Director regarding the order of candidates for enrollment in studies within three days from the date of publication of the ranking list of registered candidates. The School Director shall decide on the complaint referred to in paragraph 1 of this Article within three days from the date of filing the complaint. A participant in the competition may file an appeal against the Director's decision to the School Council within three days from the date of receipt of the decision. The Council shall decide on the complaint within three days from the date of filing the complaint. The Council's decision shall be final.

**Tuition:** The annual tuition fee for master's degree studies for the 2026/2027 academic year is published on the School's noticeboard and website.
